

## WONDERS OF WALKING WILLAMETTE VALLEY RELAY

July 20-21,2007

### VOLUNTEERS' DRIVING INSTRUCTIONS

#### **START: Champoeg State Heritage Area, Riverside Day Use Area**

From Highway I-5, take Exit 278 (Donald/Aurora). Follow State Park signs west 3½ miles. Turn right on Case Rd and go 2½ miles to park entrance. Turn right into park, then left after ticket booth. Drive about a mile to the Riverside Day Use area and the Start.

#### **STAGING AREA #1: Ferguson's Fragrant Nursery, 21763 French Prairie Rd NE, St Paul, 97137**

From Highway I-5, take Exit 278 (Donald/Aurora). Go West 5+ miles to French Prairie Rd. Turn right. **Caution - watch for walkers crossing McKay Rd.** Park in parking lot of Ferguson's Fragrant Nursery on your left.

#### **STAGING AREA #2: French Prairie Gardens, 17673 French Prairie Rd NE, St Paul, 97137**

From Highway I-5, take Exit 271 (214/Woodburn/Silverton). Go West on Hwy 219 (to St Paul), past Butteville Rd and Arbor Grove Rd. At about 4 miles, you will be making a hard right to stay on Hwy 219. **Caution – watch for walkers crossing the road.** In less than a mile, watch for the Garden on the left to find parking.

#### **STAGING AREA #3: St Louis Catholic Church, 14013 Manning Rd, Gervais, 97026**

From Highway I-5, take Exit 271 (214/Woodburn/Silverton). Go West on Hwy 219 (to St Paul) approximately 2 miles. Turn left on Arbor Grove Rd. A hard right curve (3+ miles) becomes DeConinck Rd and the next hard left becomes Manning Rd. Stay on Manning Rd another 1½ miles and you will see the church and parking on the right. The exchange is at the end of Manning Rd on St Louis Rd.

#### **STAGING AREA #4: Gervais High School, Gervais, 97026**

From Highway I-5, take Exit 271 (214/Woodburn/Silverton). Go West on Hwy 219 (to St Paul). Turn left on Butteville Rd (to Gervais). At about 3½ miles, the road curves left and becomes Ivy Ave. After crossing the railroad tracks, turn right on 3<sup>rd</sup> St. Go 4 blocks to stop sign (Douglas Ave) and turn left. **Caution – watch for walkers crossing from the right.** Park on the right in the school parking lot.

#### **STAGING AREA #5: Country Wedding Chapel & Grange, 9171 Nusom Rd NE, Salem, 97381**

From Highway I-5, Take Exit 263 (Brooks/Gervais). Go East on Brooklake Rd. Cross Hwy 99E (to Mt Angel). After 2½ miles, turn right on 65<sup>th</sup> Ave, then the next left on Labish Center Rd. At the next intersection (4 mi), stay straight (do not turn left on 72<sup>nd</sup> Ave). At 5 miles, follow road as it curves right. One more mile, cross Howell Prairie Rd and look for parking at the Grange on your left. **Caution – watch for walkers crossing from your left on Howell Prairie Rd.**

**STAGING AREA #6: Pratum Elementary School, 8995 Sunnyview Rd NE, Salem, 97305-9554**

From Highway I-5, take Exit 256 (Market St). Turn east on Market St to Lancaster Dr (second signal). Turn left (to 213), then turn right at next signal (Sunnyview Rd). Drive 5 miles to Howell Prairie Rd. Continue on Sunnyview .4 miles and look for parking at the School on your left. **Caution – watch for walkers crossing the road to the exchange.**

**STAGING AREA #7: Macleay General Store and Grange, 8342 Macleay Rd, Salem, 97301**

From Highway I-5, take Exit 253 (Hwy 22/99E/Stayton/Detroit Lake) and head east on Hwy 22. Take Exit 4 (Gaffin Rd) and follow it to the left to go under the overpass. The road becomes Deer Park Dr and then 62<sup>nd</sup> Ave(at Culver). Turn right on Macleay Rd (stop sign –3.8mi) and drive to town of Macleay. After crossing the railroad track, look for a right hand turn into the Grange parking lot. (**caution – watch for walkers after 5.3 miles**).

**STAGING AREA #8: Aumsville Elementary School, 572 N 11<sup>th</sup> St, Aumsville, 97325**

From Highway I-5, take Exit 253 (Hwy22/99E/Stayton/Detroit Lake) and head east on Hwy 22. Take Exit #7 (214-Silver Falls State Park). Turn right (to Aumsville), then turn left on Aumsville Hwy. **Caution – watch for walkers crossing from your right.** Go another 2.3 miles and turn left at the 2<sup>nd</sup> driveway into Aumsville Elementary School.

**STAGING AREA #9: West Stayton School, West Stayton Rd**

From Highway I-5, take exit 253 (Hwy22/99E/Stayton/Detroit Lake) and head east on Hwy 22. Take Exit #12 (Golf Club Rd). Turn right on Golf Club Rd. After 1.7 miles, turn right on Shaff Rd (stop sign). At next stop sign, turn left on West Stayton Rd. **Caution – watch for walkers crossing from your right.** Go 1.5 miles to school parking lot on your right.

**STAGING AREA #10: Church of God (Seventh Day), 7478 Stayton Rd Se, Turner, 97392**

From Highway I-5, take Exit 253 (Hwy22/99E/Stayton/Detroit Lake) and head east on Hwy 22. Take Exit #12 (Golf Club Rd). Turn right on Golf Club Rd. After Shaff Rd (1<sup>st</sup> stop sign), the road becomes Wilco Rd. In less than a mile, turn right on Stayton Rd. Travel 6 ½ miles and find parking in the church on your left. **Caution – watch for walkers crossing the road at Brick Rd (stop sign).**

### **STAGING AREA #11: Green Bridge Frontage Road at Densmore Rd**

From Highway I-5 , take Exit 242 (Talbot Rd) Go about .3 mile and turn right (To Jefferson). Go 3 miles and turn right (To Jefferson). At next major signal, turn left (To Scio/Greensbridge. .1 mile after "Welcome to Linn County" sign, turn right on Densmore Rd and find parking as directed. **Caution – watch for walkers crossing the road to exchange.**

### **STAGING AREA #12: Scio Baptist Church, 38969 NW 3<sup>rd</sup> Ave, Scio, 97374**

From Highway I-5, take Exit 253 (Hwy22/99E/Stayton/Detroit Lake) and head east on Hwy 22. Take the exit that goes to Stayton. Follow Cascade Hwy through Stayton and follow it south all the way to Scio (about 9 miles). At the stop sign at 4<sup>th</sup> and Main, **(watch for walkers crossing)** Continue straight a little and turn left into gravel parking lot of church.

### **STAGING AREA #13: Providence Vineyard Christian Fellowship, 35787 Richardson Gap Rd, Lebanon, 97355**

From Highway I-5, take Exit 233 (Hwy 20/226/Lebanon/Sweet Home) heading east. At the junction of 20/226 (5+ miles) stay left to Hwy 226. After the Lebanon Junction/Brewster Rd (almost 4 miles), follow Hwy 226 to the left and then take the next right on Fish Hatchery Dr. Go about 3 miles to next stop sign and turn right on Richardson Gap Rd – **caution: you will be joining the relay here.** Go another mile and park on the left in the church parking lot.

### **STAGING AREA #14: Timeless Garden, 33427 Brewster Rd, Lebanon, 97355-7118**

From Highway I-5, , take Exit 233 (Hwy 20/226/Lebanon/Sweet Home) heading east. At the junction of 20/226 (5+ miles) stay left to Hwy 226. At the Lebanon Junction (almost 4 miles) turn right on Brewster Rd. Go about 5 miles and turn left into the garden parking lot – **caution, watch for walkers.**

### **STAGING AREA #15: Family Bible Fellowship, 2600 Stoltz Hill Rd, Lebanon, 97355**

From Hwy I-5 North, take Exit 233 (Hwy 20/226/Lebanon/Sweet Home) heading east. At the junction of 20/226 (5+ mile) stay right heading to Lebanon (Hwy 20). Go through Lebanon about 3 or 4 signals and turn right on Airport Rd. Turn left on Stoltz Hill Rd. (.6mi) – **caution: watch for walkers.** Go ½ mile and turn right into church parking lot.

From Hwy I-5 South, take Exit 228(Hwy 34/Lebanon/Sweet Home) and head east about 8 miles to Hwy 20 heading to Lebanon. Go through Lebanon about 3 or 4 signals and turn right on Airport Rd. Turn left on Stoltz Hill Rd. (.6mi) – **caution: watch for walkers.** Go ½ mile and turn right into church parking lot.

**STAGING AREA #16: Plainview Mennonite Church, 34414 Plainview Dr, Shedd, 97377**

From Hwy I-5, take Exit 228(Hwy 34/Lebanon/Sweet Home) and head east. Go about ½ mile and turn right on Seven Mile Ln. After another 5 miles, veer to the left (Boston Mill Rd on the right). After another ½ mile, turn left onto Plainview Dr. **Caution: watch for walkers.** After one more mile, turn right into church parking lot.

**STAGING AREA #17: Teen Challenge International, 31700 Fayetteville Dr, Shedd, 97377**

From Hwy I-5 North, take Exit 228 (Hwy 34/Lebanon/Corvallis). Head west towards Corvallis. Take Hwy 99E exit south towards Junction City. At Shedd, turn right on Fayetteville Dr. **Caution: watch for walkers.** Parking is .4 mile on the left in the parking lot.

From Hwy I-5 South, take Exit 216 (Hwy 228/Halsey/Brownsville). Turn west towards Halsey. At Halsey, turn right on Hwy 99E. Drive to Shedd (about 5 miles) and turn left on Fayetteville Dr. **Caution: watch for walkers.** Parking is .4 mile on the left in the parking lot.

**STAGING AREA #18: Peoria Park Boat Ramp**

From Hwy I-5 North, take Exit 228 (Hwy 34/Lebanon/Corvallis). Head west towards Corvallis. Take Hwy 99E exit south towards Junction City. At Shedd, turn right on Fayetteville Dr. Go about 5 miles to Peoria Rd and turn left - **caution: watch for walkers.** Drive .3 mile to parking on the right.

From Hwy I-5 South, take Exit 216 (Hwy 228/Halsey/Brownsville). Turn west towards Halsey. At Halsey, turn right on Hwy 99E. Drive to Shedd (about 5 miles) and turn left on Fayetteville Dr. Go about 5 miles to Peoria Rd and turn left - **caution: watch for walkers.** Drive .3 mile to parking on the right.

**STAGING AREA #19: Lake Creek Mennonite School, Peoria Rd, Halsey, 97348**

From Hwy I-5, take Exit 216 (Hwy 228/Halsey/Brownsville). Turn west to Halsey. At Halsey, turn left on Hwy 99E. Drive two miles to Lake Creek Dr and turn right. Drive 4 more miles to Peoria Rd and turn right – **caution: watch for walkers.** School is .1 miles on your right.

**STAGING AREA #20: Harrisburg Gazebo at Boat Ramp**

From Hwy 1-5, take Exit 209 (Harrisburg/Junction City). Go west on Diamond Hill Dr to Harrisburg (5.4 miles). At N 7<sup>th</sup> St, turn left. At end, turn right on Smith St. Drive to 1<sup>st</sup> St and park in Credit Union parking lot on the left

**STAGING AREA #21: Lyle Day Park, 5<sup>th</sup> & Deal, Junction City, 97448**

From Hwy 1-5, take Exit 209 (Harrisburg/ Junction City). Go west on Diamond Hill Dr to Harrisburg (5.4 miles). At N 7<sup>th</sup> St, turn left. At end, turn right on Smith St. Drive to 3<sup>rd</sup> St and turn left. Follow it over the bridge as it becomes 99E. – **caution: watch for walkers on your right.** At about 4 miles Hwy 99W will merge with Hwy 99E. – **caution: watch for walkers crossing the road here.** Follow Hwy 99 into town and turn left on 6<sup>th</sup> Ave. Go 6 blocks to Deal St and turn right – **caution: watch for walkers.** Parking is on residential streets, use common courtesy.

**STAGING AREA #22: Lone Pine Fruit Farm, 91909 River Rd, Junction City, 97448**

From Hwy I-5, take Exit 195B (Junction City/Florence) Go west 4 miles to Exit 8 (River Rd/Santa Clara). Turn right on River Rd and travel north approx. 4 miles to parking on the right. – **caution: watch for walkers.**

**STAGING AREA #23: Faith Center Foursquare Gospel Church, 151 River Ave, Eugene, 97404-2545**

From Hwy I-5, take Exit 195B (Junction City/Florence) Go west 4 miles to Exit 8 (River Rd/Santa Clara). Turn left on River Rd getting in 3<sup>rd</sup> lane over (lane marked "To Eugene"). Turn left on River Ave (2<sup>nd</sup> signal after crossing under freeway overpass). Go about .1 mile and turn left in parking lot of church – **caution: watch for walkers.**

**FINISH AREA (SA #24): Alton Baker Park, Eugene**

From Hwy I-5, take Exit **194B** (Hwy 105/126/Eugene) to the right. Take Exit #2, following signs to Autzen Stadium. After split, get in left lane then go through light at Coburg Rd and turn left on Southwood Ln. Turn left at Country Club Rd (signal). Go straight at next signal. After crossing under bridge, turn right at next road (Day Island Rd) into Park (at LaQuinta Hotel). Watch for signs for Alton Baker Park. Enter parking lot. Finish is at far end of parking lot to the the right.
